PLEASE READ & SIGN THE FOLLOWING RELEASE: In consideration of the acceptance of my application for the above activity, I hereby waive, release, and discharge any and all claims for damages for death, personal injury, or property damage which I may have, or which may hereafter accrue to me, as a result of participation in said event. This release is intended to discharge in advance the Releasees named below.

I further understand that serious accidents occasionally occur during bicycle riding, and that participants in bicycle events occasionally sustain mortal or serious personal injuries, and/or property damage, as consequence thereof. I hereby agree to indemnify and hold harmless all of the Releasees, for any and all damages, costs, claims, liability, judgments or expenses, including attorney's fees incurred in prosecution of this indemnification, which may arise directly or indirectly as a result of my conduct during or in relation to this event. I further agree that this release and waiver shall also apply to all unknown and unanticipated claims and hereby waive the benefits of California Civil Code Section § 542, which provides that "a general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release which if known by him must have materially affected his settlement with the debtor."

It is also understood and agreed that this waiver, release and assumption of risk is binding on my heirs and assigns. I agree to accept and abide by the traffic laws of the State of California, all county and city ordinances which may apply to this event, and the directions provided by the Rotary Club of Healdsburg Sunrise.

I understand that I am responsible for providing a bicycle in safe operating condition and for wearing a safety helmet during my ride. I hereby assume all risk for myself and all liability to others for my failure

to have complied with any and all applicable laws, event rules, safety regulations and precautions and/or for failure to inspect my bicycle and equipment.
